In addition to the documentation submitted today, we attach two further photographs that have recently come to light which we think might help the Inquiry.

We are aware that the expert witness testimony has focused on the functionality and operation of the lift fire control switches at the Grenfell Tower.

The attached photographs were taken by our engineering surveyor prior to Apex quoting for work on the new door entrances in 2014. The filenames suggest these pictures were taken on 17/07/2014

We believe these photographs show the fire control switches on the ground floor of Grenfell Tower at this time.

They appear to be the original switches installed by Apex when the lifts were refurbished in August 2005.
