Dear Bruce,

It was good to see you yesterday.

Is it possible if you could draft a brief scope of works required for Grenfell Tower and your propose specification so that I can use them to prepare the budget estimate?

1. From what I understand from yesterday meeting, two possible options for external cladding: -
 - (a) Rainscreen cladding (I probably will allow Zinc cladding on Metsec steel, do let me know if you think otherwise)
 - (b) GRP panel?
2. Windows: -
 - (a) To remove all existing windows and replace with double glazed windows? Or add extra glass layer to existing single glazed window?
 - (b) Assuming the existing windows are Aluminium frame window?
3. Heating System: -
 - (a) Isolating existing communal boiler
 - (b) New boiler and providing independent heating system to each unit?
4. Podium:
 - (a) To convert Boxing Club to Nursery?
 - (b) To convert exiting Nursery to 4 unit residential flat?
 - (c) Fill/create floor to the void in Boxing Club?

Have you spoken to any cladding specialists, if so, do you mind forward their contact details or any information they have provided to you?
