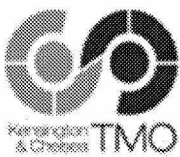

The recommendations within the addendum are in line with our discussions of last week, and allows us to progress towards re-procuring the construction.

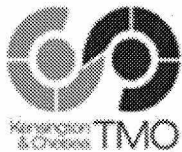
