Further to our meeting on Monday in relation to the H&S file, I confirm:

- 1 TMO approach on informing residents of any asbestos in their homes (see email below)
- 2 I have raised the issue of fire signage with our fire assessor, where the newly formed lobby service cupboards visually obscure the fire door to the single exit staircase. He has checked the regulations and has said that there is no need for any signage to direct residents and will put this in writing. He has been involved with Grenfell for many years and met the Fire Brigade there a couple of times, so I am reassured that his advice is good; as well as him having ongoing responsibility.
- 3 Abseiling or sky cradles for external maintenance of the building: we assess each building on its own merit, there is no overall policy. At yesterday's site meeting we asked for the manufacturer's information on the maintenance of the cladding, which needs to be provided so the design team can come up with a strategy. (Nick/Neil: see item 2.1 in attached minutes which discusses discharging detail through conditions).

Keith, I could not find the actual F10 in my directory, but I found information relating to it – giving a start date of 24 March 2014, pc 62 weeks later. Can you please check this and let me have the actual F10 that allows for a completion date of 23 October 2015 (or later)?
