Hi Claire.

I am delighted to hear that you have delivered the contract. Big milestone achieved.

I would be very surprised if there is any issue with building regulations with the windows. So I hope that you are not holding up getting approval from Peter and David while you wait for Rydon to confirm.

I had a quick review of the NBS spec in the tender docs for cladding and it does specify the cladding must comply with the following standards, one of which I would anticipate requires flame retardance. However as client I suggest you seek clarification from Rydon:

Compliance standard: The Centre for Window and Cladding Technology (CWCT)
'Standard for systemised building envelopes'.

Comply with the recommendations of GRCA publications
'Specification for the manufacture, curing and testing of GRC products' and 'Guide to fixings for glass fibre reinforced concrete cladding'.

Structural and fire requirements:

- Generally: As section B50.
- Modifications: None.
- Design: Complete the design in accordance with the designated code of practice to satisfy specified performance criteria.

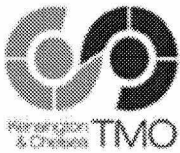

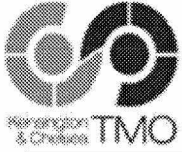
