I've had a read of the email below. I'm not sure there is anything I can add from Rydon's point of view that we aren't doing already. At the moment we contact the resident for the condition survey in their property and they either allow us access or not. Every resident which tells us that they are refusing access is referred to yourself straight away via email and moved to the end of our programme. At no time is 'pressure applied' to the resident by ourselves.

If you have a list of the 'Concerned Grenfell Tower Residents' from Mr Daffarn and instruct us not to visit or contact them then we will do so. Let me know how you wish us to proceed.

On Sunday 8th March a number of concerned residents undertook a door knocking exercise in Grenfell Tower to measure the level of support for an Emergency Resident's Meeting to discuss the lack of consultation by TMO/Rydon and to respond to the threat that TMO/Rydon intend to place new boilers in residents entrance hallways in order to cut costs.

We are amazed at the level of support and solidarity that we received from residents and we are now intending on holding an Grenfell Tower Emergency Meeting on Tuesday 17th March at 6.45pm so that tenants and leaseholders can gather to discuss how residents can come together collectively to ensure that all residents are treated with respect by TMO/Rydon now you require entrance to our homes.

In the meantime, a number of residents have requested that TMO/Rydon do not enter their properties until residents have had a chance to meet together on 17th March and we are asking that the TMO/Rydon respect these residents wishes and do not apply pressure to continue with works inside these properties.

Thank you for your understanding of these issues and we trust that you will want to work with residents in a constructive manner to ensure a smooth resolution to these concerns.
