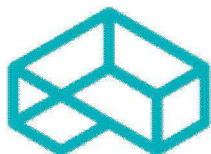

Thank you for your feedback!

Indeed, I'm not fully familiar with your procedures, but I've been used to lead the biyearly Product audits for France, Ukraine, Poland and Germany for at least 3 years. Hopefully, we should manage to complete it according to your way of doing.

Regarding the modification about the name, the logo and the address of the Company: It is just an administrative modification. The company hasn't been bought, we just change our name and logo. For the address, same thing, our plant is still at Merxheim but the name of the street has been changed.

Regarding the requested documents:

1 - We cannot provide a written confirmation that there were no changes in our process. Please find enclosed to this mail a draft of our last "Assessment for Production" where I noticed every actual changes (Highlighted in the document). Please let me summarize it below:

Page 1- We added the relevant reference number for Reynolux Coated Aluminium Sheet and Coil

Page 2- Change of the name and the address (But as I understood from your last mail, this modification shall be made afterwards)

finish

Page 3- "PVDF" becomes "PVDF 70/30"– This is the actual full name of our paint

Page 4- "Quality certificate CC-FSR-xxx" becomes "...CC-FSR-075"

Page 5- Acceptance limits for RB becomes "+/- 0.2 mm"

Page 5- Acceptance limits for GP and Reynodual must be deleted, as GP is absolutely not a Building product, and as Reynodual is not covered by this assessment

Page 6- « FR > 25 PLI (INOX) » becomes « FR > 40 PLI (INOX) »

Page 6- GP is also deleted in the T-Peel acceptance limits

Page 6- Packaging: Plates are now packaged on palettes according to ISO procedures "MCA-FP-0009 to MCA-FR-0013"

Page 6- Certification symbol: "Qb 3747" instead of "CSTB CERTIFIED 4736"

2 - Could you please precise what kind of specific document you are requested ? **Technical data sheets, commercial brochures, installation manuals that are dispensed across the UK. Also CE marking data since you state below that your product is now CE marked.**

3 - Our policy doesn't allow us to provide this kind of document, as it is strictly confidential. However, it will be of course fully available on site during your visit.

4 - Same remark than above

Also, I would like to ask a few question, just to keep these things in head:

- Our REYNOLUX product is now CE marked. Would it mean that the audits for Reynolux products by BBA are no longer necessary? To be honest, It would be great if we could both save some time...

No, I am afraid. This is not the case.

- If not, we would like to run the two audits for both products Reynobond and Reynolux at the same time at Merxheim, like it happened beginning of this year. Could we plan this when it is the good time?

Yes, this can definitely be done. I will be in touch with our inspection team on this regard.

Please send me your feedback regarding these first answers, I stay at your full disposal if you need any information.

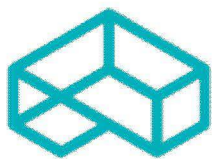
