- 1. METROPOLITAN POLICE SERVICE to provide clearer timeframe for ongoing site investigations for Ministerial meeting.
- 2. DEPARTMENT OF WORK AND PENSIONS to work with DEPARTMENT OF COMMUNITIES AND LOCAL GOVERNMENT and HM REVENUE AND CUSTOMS to report quickly any concerns from staff on the ground into METROPOLITAN POLICE SERVICE.
- 3. LA GOLD to provide a summary of resources deployed on the ground.
- 4. LA GOLD to report any concerns over resourcing from departments through DEPARTMENT OF COMMUNITIES AND LOCAL GOVERNMENT.
- 5. CABINET OFFICE COMMS, working closely with LA GOLD COMMS, to finalise leaflet today summarising key information for local residents.
- 6. DEPARTMENT OF WORK AND PENSIONS to work with DEPARTMENT OF COMMUNITIES AND LOCAL GOVERNMENT to ensure no interruption of welfare payments to victims.
- 7. All Departments to note no Ministerial visits to the Grenfell area today at request of LA GOLD.
- 8. DEPARTMENT OF COMMUNITIES AND LOCAL GOVERNMENT to work with LA GOLD on list of tasks for Victims Unit, and departmental secondments required for the Unit.
- 9. LA GOLD and DEPARTMENT OF WORK AND PENSIONS to ensure all affected victims are able to receive support payments into accounts by Monday.

- 10. NUMBER 10, HMT and DEPARTMENT OF COMMUNITIES AND LOCAL GOVERNMENT to clarify interaction between urgent welfare payments and Discretionary Fund.
- 11. METROPOLITAN POLICE SERVICE, LFB and DEPARTMENT OF COMMUNITIES AND LOCAL GOVERNMENT to ensure all information which can be shared on fire risk factors is shared, to allow rapid assessment of other 'at risk' buildings across the country. This should include lists of customer details from suppliers if relevant.
- 12. CIVIL CONTINGENCIES SECRETARIAT and DEPARTMENT OF COMMUNITIES AND LOCAL GOVERNMENT to find additional capacity to undertake fire safety check calls across the country.
- 13. DEPARTMENT OF COMMUNITIES AND LOCAL GOVERNMENT to provide options, in advance of tomorrow's Ministerial meeting, for public reassurance packages while fire safety checks ongoing.
- 14. CIVIL CONTINGENCIES SECRETARIAT and DEPARTMENT OF COMMUNITIES AND LOCAL GOVERNMENT to engage GO-SCIENCE on scope to rapidly upscale laboratory testing capacity on fire safety checks.
- 15. CIVIL CONTINGENCIES SECRETARIAT to convene departments on Monday to coordinate identification and checking of 'at risk' public buildings.
- 16. DEPARTMENT FOR BUSINESS ENTERPRISE AND INDUSTRIAL STRATEGY Ministers / senior officials to urgently engage with key trade bodies and companies on white goods recalls.
- 17. LA GOLD, DEPARTMENT OF COMMUNITIES AND LOCAL GOVERNMENT and HOME OFFICE to ensure clear link-up between local authority and Departmental comms teams.
- 18. LA GOLD to confirm requirement for support/advice for logistics, and site recovery and engineering to MINISTRY OF DEFENCE. MINISTRY OF DEFENCE to deploy required resources today.
- 19. DEPARTMENT OF COMMUNITIES AND LOCAL GOVERNMENT and HOME OFFICE to provide community cohesion expertise today, to support LA GOLD.
- 20. DEPARTMENT OF HEALTH to engage with MAYOR'S OFFICE on psychosocial support available for those affected by the incident who are not from emergency services.
- 21. CIVIL CONTINGENCIES SECRETARIAT to engage with FOREIGN AND COMMONWEALTH OFFICE to ensure arrangements in place to support foreign nationals involved in the fire.
