Hi there

We are ready to send over the full test report to Warrington Fire. The NDA has been signed.

Frans is very busy with overseas trips and then a holiday so will be able to report back on his findings early April.

We have agreed to send over 4-5 build-up examples. After consideration and a discussion with NHBC, the following have been recommended.

- Design 1: Inside to out
2x 12.5mm Plasterboard
100mm SFS
12mm Calcium Silicate Board – A1

100mm Celotex RS5000
Unventilated Cavity
103mm Brickwork Façade
Stainless Steel Ties

- Design 2: Inside to out
2x12.5mm Plasterboard
100mm SFS
12mm Calcium Silicate Board – A1
100mm Celotex RS5000
Ventilated Cavity
8mm x Terracotta Cladding
Brackets and rails

- Design 3: Inside to out
2x12.5mm Plasterboard
100mm SFS
12mm Calcium Silicate Board – A1
100mm Celotex RS5000
Ventilated Cavity
Cladding Laminates – A1
Brackets and rails

- Design 4: Inside to out
2x12.5mm Plasterboard
100mm SFS
12mm Calcium Silicate Board – A1
100mm Celotex RS5000
Ventilated Cavity
Cladding - Aluminium – Class O
Brackets and rails

I think these best represent what's commonly specified and in particular what NHBC commonly see. The analysis will hopefully help us to better understand the risky parts of cladding systems.

If we are agreed on the above I will send over the report and suggested build ups.
