Guidance on specification of RS5000 in buildings with a storey height greater than 18m

Local Authority Building Control

Where projects are subject to Local Authority Building Control, U value calculations will be issued. However every calculation will be sent out with the below set of words as well as the Rainscreen Cladding Compliance Guide.

Where the construction features a masonry outer leaf, concrete substrate or is otherwise substantially different from our tested system then the additional paragraph can be appended.

Thank you for your enquiry.

Celotex RS5000 has been successfully tested to BS8414 part 2 and so can be considered for use in buildings above 18m.

Please find attached a copy of our Rainscreen Cladding Compliance Guide which gives details of our fire test and some background to the building regulations requirements.

It will be the responsibility of the building control body to judge compliance on a project by project basis. We would recommend showing them the compliance guide and the details of your proposed system and have a discussion with them as early in the design process as possible.

Additional paragraph for masonry outer leaf, concrete substrate or other cases where the proposed design differs substantially from our tested system.

It is worth noting that our tested system was comprised of an external rainscreen façade and SFS frame. Where your design differs from the tested construction then this should become a discussion point with the building control body. It is critical that compliance is agreed before the design is finalised or work commences on site.

NHBC

Where projects are subject to NHBC requirement we will identify the given construction and unless it exactly matches the specification given in our literature we will advise that the use of Celotex is not supported.
