1. As structural work is being undertaken within this building as part of this project has a Building Regulations application been made for the work/project? tRIIO has not been requested to submit a Building Regulations application for these works and this has not previously been requested for our works.

This work is a notifiable Building Control issue who has submitted the Building Regulations application for this work, what does the contract say?

2. All holes in compartment wall must be suitably fire stopped using fire rated materials of a minimum of 90 minutes fire rating. Once the pipe network is installed we will box in to provide fire protection and seal holes that are not needed to provide a flow of air through the boxed sections.

All holes in any compartment wall lining must be sealed and suitably fire stopped using fire rated materials of a minimum of 90 minutes fire rating. There can be no holes or gaps left where pipes penetrate compartment wall or ceiling linings.

3. Documentation should be provided by the gas contractor showing the fire rated materials used for the fire stopping of the compartment walls and the fire rating of the fire collars used.

On completion of our works we will provide documentation to confirm the fire worthiness of our installation.
