Good Afternoon

So, finally I have spoken with someone senior in National Grid as having had limited or no response from their agent regarding Grenfell Tower and Chesterton Square.

In relation to both sites it seems like their intention is to box in the riser recently installed but as works have not yet finished on site this is not yet completed. I have asked for a date they anticipate this to occur and they are to come back to me on this today. They had indicated a carpenter has been on site this week to measure this area at Grenfell Tower.

I have also asked for a detailed explanation of their requirements when installing a riser of this nature so we have some detail to respond to the residents at Grenfell as once the boxing is installed this would prove no further risk than the original riser in the fabric of the building.

I have requested we meet on site early next week and wonder if Janice could arrange for Carl and the FB to meet to discuss their installation and any works the FB may deem necessary. Looking at Carls previous report and the comments from the contact Janice has at building control it seems boxing is the main concerns.

I think that speaking in detail with this contact today it may be the residents have jumped the gun before the install is fully complete but will give a further update once the site visit occurs next week and hope to have these wrapped up ASAP.
