Further to your email below and Janice's subsequent email with Carl's report I can advise that I initially contacted Mr Samuel in July 2014 following a meeting with Jerry Gilbert regarding other fire proofing works that were outstanding at a number of properties in following a scheme carried out by the TMO previously. It was then highlighted to me that there was also an issue with Mr Samuel's front door not being compliant and reference to that was added to my exchanges with him and/or his PA. A chronology of my exchanges is detailed below and copies of the correspondence attached as requested:-

- \cdot 10th July 2014 email from David Ward [DW] to Richard Samuel's [RS] highlighting the outstanding fire proofing works
- · 26th August 2014 Reminder email from DW to RS asking for an update and also reference to the front door that I was advised was potentially not compliant
- \cdot 31st October 2014 acknowledgement from RS and note that his PA [PA] would be looking into the issues raised
- · 3rd November 2014 email from PA to DW advising that she was looking into these matters
- · 17th November 2014 further email from PA to DW advising that there is substantial paperwork in respect of the property and she'd therefore need additional time
- 8th December 2014 email exchange between DW and PA re outstanding information with the latter advising that they hope to provide a response before Christmas
- Ow's initial email of the 10th July but without reference to the compliance of the front door
- \cdot 8th January 2015 email from DW to RS asking for evidence that the front door was compliant as this was not addressed in his prior email

I have had no further communication since but can write, if you think appropriate, a further email today in respect of solely the front entrance door whilst also providing a copy of Carl's report with a mention also to the matter being referred to RBKC Legal but I'll be guided by you on this proposal and also any wording you want included.

Please see below, and amend as necessary. Not sure where we are with the final door? Work is continuing in relation to the issue of leaseholder flat entrance doors which are not compliant with fire safety standards. In March 2014 we reported that we had been working with the householders of 37 doors that had been assessed as non-compliant. This had gone down from a high of 107 doors in December 2013. 35 of these households have now provided evidence of their doors being compliant, this leaves 2 households with non-compliant doors. One of the two remaining households who have a non complaint door is an elderly leasehold who has stated she can't afford to replace the door.

After investigating her situation arrangements have been made for the door to be replaced and the

leasehold re-charged for the costs.

A date has been agreed for a new complaint door to be fitted (will try and get date from Staying First). An affordable monthly plan has been agreed with the leaseholder.
