I am looking at the fire detection arrangement for the whole building, as we have changed the layout – and I don't know if this has come back to you.

I attach the plans of the 4 lower floors, showing:

Ground floor

no concierge, community room, nursery this layout is not quite right on

the last drawing 'proposed floor plans' rev00.pdf, but is close enough. The staircase at the front of the building going up to the next floor has been removed).

<u>First floor</u> (formerly mezzanine) 4 flats, storage room for use by the TMO Second floor (formerly walkway) boxing club (entrance at ground floor), 1 flat

Third floor (formerly walkway +1) 4 flats

We have effectively removed the concierge, and our housing office – but added ground floor community rooms and facilities. Can you please let me know if this changes your advice as below?
