25/8/2016 - Husna sends video of inside their flat

26/8/2016 to 29/8/2016 - They moved from Edmonton to Grenfell over the long Bank Holiday weekend

7/9/2016 to 27/9/2016 - [redacted]

* Meeting with Council around 23/24th August 2016

- Mudday appt (lasted approx 1.5hrs)
- Rabeya, Hanif and Rohema
- Met with Housing Office after very long wait
- Private interview room on far right. Desk: wall to wall
- Officer was taken aback by my presence
- Possibly took my name and relationship to Rabeya
- Rabeya thought that they would discuss housing options, but said she felt they would force them to move again
- The Officer produced a letter offering 142 Grenfell stating it met their requirements.
- It has a lift, the right number of bedrooms and in the locality of C+W hospital for Kamari and Namud to attend follow-ups.
- My aunt and Hanif refused. It's on the 14th floor with a man who has had strokes/heart attacks and elderly - not safe or practical.
- The Officer forcefully insisted that they had to take this property, otherwise they would be

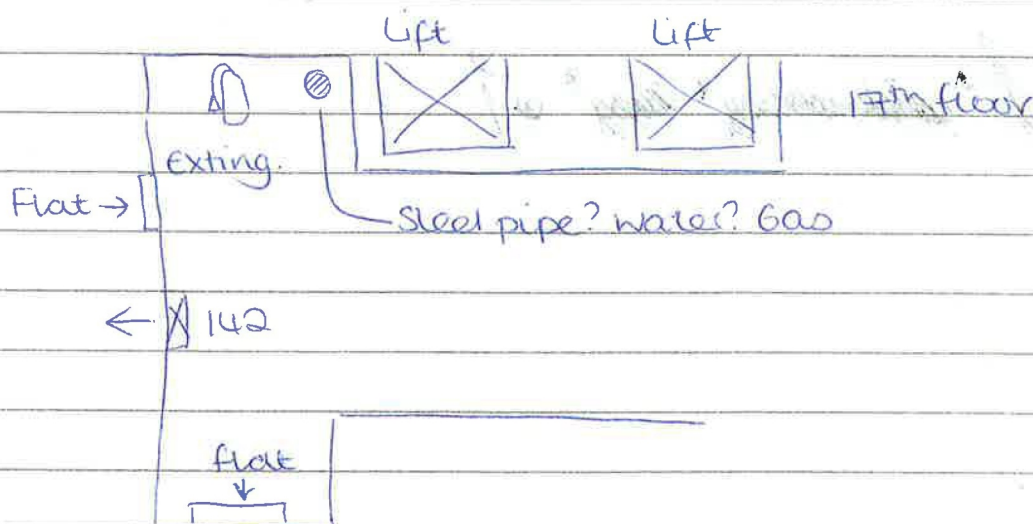
making themselves homeless. They would not house them if they did so.

- I argued it was their duty of care to elderly residents to house them anyway but safely.
- How could you possibly reach somebody on the 14th floor if the lifts are not working?
- Officer stated that a previous assessment of their case mentioned that accommodation with a lift would suffice.
- Rabeya told them (I interpreted) that the circumstances have changed since the strokes, and why would they move them from a 1st floor flat to the 14th floor knowing Kamru was so ill.
- Why had they not considered his illness
(property at Edmonton was private rental, paid for by RBKC) - the owner was selling this flat.
- Hanif protested that they would take something smaller, but on the lower floors of anywhere.
- The officer seemed annoyed that they weren't giving in and accepting the flat.
- She threatened that this would be their last offer, despite saying it was only another temporary offer. I asked why can they not find a permanent place, she said that was not an option at this stage. I asked again, with temporary accommodation they would have to move them again at some point, so what she said earlier was invalid.
- After much 'discussion' the officer agreed that they would have 24 hrs to come to a decision and let the housing office know.
- My aunt went back the following day with Hanif and accepted reluctantly.

- I believe she only accepted Grenfell, because Edmonton would be sold whilst she would be at [REDACTED] and didnt want to worry about her husband being made homeless during that time.
- The housing officer did not know about their trip.

* Housing officer:

- Black female - late 20's - mid 30's
- Petite frame - 5' or under
- Shoulder length hair
- London accent, well spoken.
- Possibly caribbean
- name began with C or L, Charlene? Lorna?



- No gas at 142 for approx 4 months - Oct - feb
- Which meant no hot water for parts of it
- Rabeya said the flats on her side, up and down were experiencing the same thing
- Cooked using table top electric hob and oven
- Washing machine wasn't connected for some time
