Mohamed Omar is a trustee of the gardens of peace, Muslim burial ground. He telephoned me this morning to ask if his contact details (below) could be given to families of any Muslims who wish assistance with funerals. Mohamed is known to the judge who attend the Gardens of Peace annual conference a couple of months ago. I have said all I can do is pass the information on to you so it could maybe be cascaded to the FLO's. Further to our telecon , I totally appreciate that the Westminster coroner is inundated with a heavy work load , however , there is concern amongst the families about the remains of the deceased and the process of release . The judge and you are aware that we represent the Muslim community on all matters relating to this aspect and I just want to make her life easy with a single point of contact .

We are also the largest dedicated Muslim cemetery and a sizeable number will be buried at our cemetery It could be good if we could also be given the details of the chief family liaison officer so that we can talk to them as well . These are trying times for the community and the incident this morning in Finsbury Park has not helped .
