Subject: Summary of Local Authority Teleconference - Finsbury Park Incident 19 June

#### Situation

Approx 0020 on Monday 19 June there was an incident near the Moslem Welfare House (off Seven Sister's Road). People exiting the mosque were giving first aid to a person who had collapsed when a white van was driven into the group resulting in one dead and (tbc) 8 injured. The van driver was detained by people at the scene then arrested by police. Cordons in place with impacts on traffic in Islington and neighbouring boroughs.

LB Islington opened its BECC, opened an FFRC at the request of MPS and Chief Exec and Leader deployed to scene overnight – local action being taken on community issues including visit by Jeremy Corbyn. Command arrangements:

- MPS declared this a Plato incident. Multi-agency aspect of that response now closed and MPS at pan-London level are treating this as a police issue. Counter-Terrorism Command is investigating
- · Borough Multi-agency Gold planned for 1100 today
- COBR meeting planned for 1000 today.
- From Local Authority perspective LB Islington is leading.
- Action Lesley Seary to forward info from Borough Gold meeting if possible, by text, to John Barradell

## **Community Impact**

- Crowds gathered in area at around 0130 but quiet by 0600.
- Local concerns at first police statement which mentioned "mental health assessment" for the arrested person. Local concern at perception of "whites get mental health assessment/blacks get called terrorists"
- Various baseless rumours in the area early in the morning
- Concerns also at length of time for MPS to issue statement this would have helped manage rumours locally.
- Moslem Welfare Centre mosque, with support of LB Islington have issued statement.
- Some concern around potential for spread of tension across London, especially because of media reports linking the incident to the Finsbury Park Mosque (which is incorrect)
- It is Ramadan:
  - o Prayers at night therefore mosques are busy at night
  - o In Islington women have expressed fears for their safety travelling to an from mosques at night
- Actions
  - o Lesley Seary to forward copy of Moslem Welfare Statement if possible.
  - o Hamish Cameron to communicate with Faith Sector Panel to ensure chair is aware

# **Community Cohesion**

In addition to actions above:

- London PREVENT staff communicating with local contacts to collect information and offer reassurance
- Home Office in touch with PREVENT network.
- Refugee Week this week
- Actions
  - o PREVENT staff to be aware of Refugee week
  - o LLACC to ask BECCS to report by exception on community cohesion issues.

# Comms with the Public

• Important that the response to the incident is seen to be as significant as an alleged Islamist terrorist incident

#### Horizon scar

- Observation that MPS in boroughs not immediately affected by the incident are deploying staff to the incidents, thereby reducing resources for community policing
- Noted that this could be a long hot summer concerns at LA and other responder resilience across London
