John, Mark,

To update you on the current situation and local authority gold considerations.

The scene is stabilising but it is clear there are a number of fatalities (6 reported on the 06.30 SCG meeting) and 60 casualties conveyed to four receiving hospitals. Mass Fatalities Coordination arrangements are being established. Fiona Wilcox is the lead Coroner. The next SCG meeting is at 08.30. A Casualty Bureau number has been [published](#). Nicholas Holgate was on the 06.30 SCG via teleconference (K&C's preferred method rather than attending SOR). David Kerry was also on that call and the previous call at 05.00. Nicholas and Chris Naylor (oncoming LALG at 09.00) are in agreement that Nicholas will lead LA engagement in the SCG. From the meetings to date I would agree that seems the best approach. Nicholas thinks that aside from housing needs which may spill over borough boundaries there is no need for LLAG to be stood up.

Chris is aware we may need to seek his approval for mutual aid requests. Although not requested by K&C, we will be staffing the LLACC to offer coordination support if required. Hammersmith & Fulham are in contact with K&C about support.

FYI – John Hetherington is on his way to SOR now and will be leading on this incident for us today. I have the Southwark HASG at 10.00 and Recovery Group at 14.00. We are supporting both of those groups so I'll probably be focussed on supporting Southwark today.

Please let me know if you need any further information at this time.
