We spoke. A couple of issues which have been fed back to us:

Communications - both the Secretary of State and Housing Minister have concerns about an RBKC communication which has said that they would be exploring housing options in other parts of the capital, which is different that the statement made by Ministers about the local area. I believe the press have picked up on this;

Housing - I have had contact from Laura Johnson who has said she is having trouble housing a family - who the Secretary of State spoke to this morning - in a house, but has found hotel accommodation. She suggested the family are not happy with this. Separately I have had a call from a Councillor who said they have found a house for the family. We have given a commitment to help with funding, but I think this is more a matter for the Council than DCLG so would be grateful if someone could pick this up. We have given a housing person from DCLG to the Council but Laura has said she has sent her away until Monday. I am not sure this is helpful as our person, Lizzie, is a useful way back into the department if there are issues.
