You and your wife shouldn't have to put up with this.

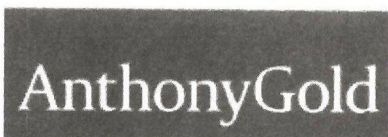
If these problems are not resolved today please let me write to Dexters and RBKC on your behalf. I would be very happy to do so and could copy in Judith Blakeman as well.

I hope this email finds both well.

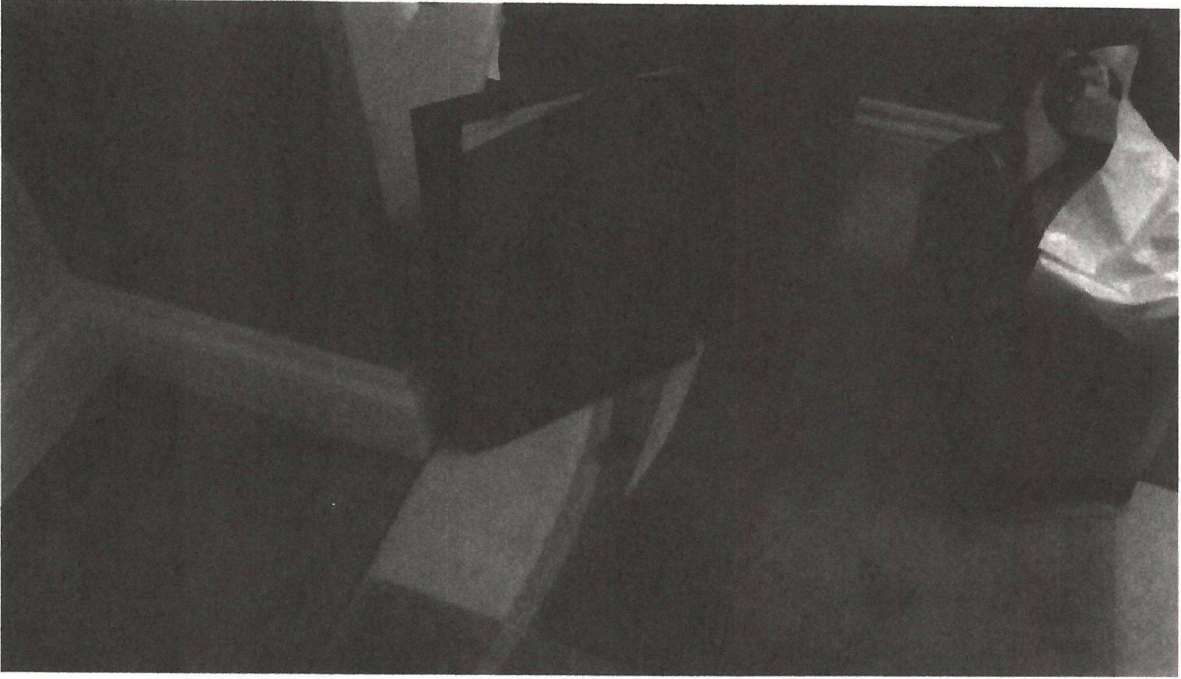
Please find attached photograph of rats running around in our living room, it makes me wonder and God knows how many around in the flat and I have already updated head of RBKC for their necessary action.

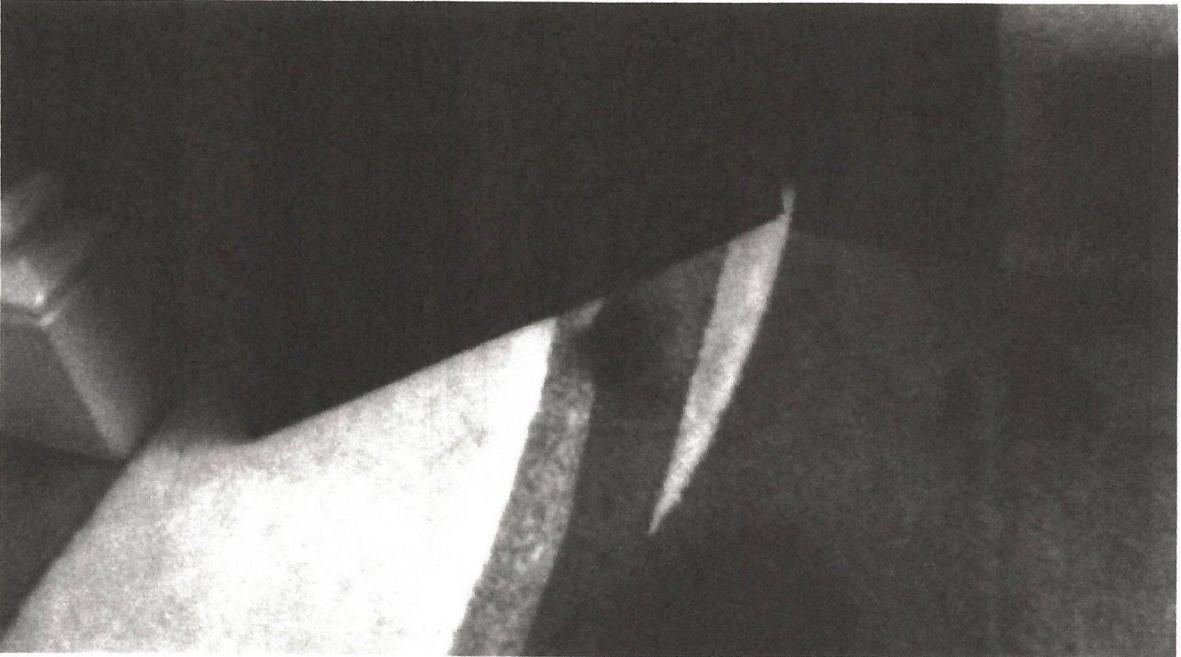
