Cllr Blakeman,

We didn't receive a report from Zurich.

We did receive a copy of a letter from Zurich to residents stating that they would not be paying any form of compensation/disturbance as they were satisfied the TMO had carried out all the necessary electrical inspections and once the problem was identified the TMO acted in an appropriate manner.

Mr Awoderu has already asked for all information relating to the power surges under a Freedom of information request and he has received the following documents, which I think are quite comprehensive:
