Morning all,

I handed her the direct offer letter. The property is more than suitable from the medical point of view.

We've agreed for her to give us a definite answer today, but if she declines it, then it is a definite refusal.

NB: we have advised Miss Lokko that major adaptations (level access shower) can be requested starting from May 2017 due to the defects liability period. Just in case she asks one of you about it.
