Dear Graham,

As promised I have summarised our current position with respect to Kooltherm K15 above 18m, I apologise for the brief format necessary due to short notice.

Firstly it is important to reiterate Kingspan continue to support Kooltherm K15 as fit for purpose in its intended application. The importance of the product is not underestimated by Kingspan this being underlined by your comment the product is currently specified in excess of 400 projects to NHBC's knowledge. Similarly we are aware of its intended use and where consulted provide very significant resource in supporting each and every project team to help demonstrate suitability.

As discussed today our test programme with BRE continues unabated, our aim is to where practical establish outer limits of some of the test variables to allows better interpretation against specific projects. It should be realised this presents some real challenges in terms of cost but more importantly availability, cycle time and the sheer myriad of variables. This includes three successful BS 8414 tests, one onto a masonry substrate (Part 1), a combustible and non-combustible cladding system onto a steel frame (BS 8414 part 2). Further to this we are expanding the scope of our

work with project specific assessments via Arup and the BRE which include alternative façade systems including traditional brick and various different claddings, alternative fire barriers, sheathings and filled stud frames fillings.

In our view the regulatory framework surrounding the application and solutions leaves some real holes in how to determine compliance, this highlights to Kingspan the importance of the Fire Engineers role in providing project specific assessment is key. We should not forget AD Part B requires all components used within the external wall build up (not just insulation) should be of limited combustibility unless large scale test evidence can be provided.

In addressing some of your specific queries around how to handle various aspect of Kooltherm K15's performance we continue to engage with ARUP and will keep you informed with progress.

Finally we would welcome the opportunity for a meeting to help determine how we can assist further. As confirmed previously and within the spirit of our ongoing co-operation we would request 14 days prior notice of any NHBC announcements concerning Kooltherm K15 to the wider industry. Please do not hesitate to contact me if I can be of further assistance.
