Following on from David's message below, thank you all for your patience while we compile all responses. We have just been given an update from Kensington regarding their requirements from tomorrow morning onwards: the shift pattern will be changing as follows:

A massive thank you to those of you who have sent in offers of mutual aid, for personnel from your Boroughs, to fill roles within the BECC and Rest Centre or as LALO or EPOs for RBKC.

Your responses have allowed us to fill in most of the slots however we still require a few (please continue to provide volunteers). At present we are waiting for confirmation that all these roles are required up until at least Monday, however will of course keep you updated.

Please see a list attached showing until Monday. If I have made any errors please let me know. Many of you have offered people for part shifts. These have not been included on the list as we are prioritising people who can do full shifts at present. We are keeping a record of these offers should we need these.

For those of you who have volunteered staff, we realise you are keen to know if these are needed, we will aim to get confirmation to you on whether your volunteers are required as early as possible before they are due to start.
