No problem – for your information, this has been one of those "hair-pulling" seriously frustrating issues, where the training creator has no idea about the subject matter, and requires such a high level of support that I'm surprised they still have a job! Bottom line on this one is that the station-based training package contains relevant information in the format agreed, with content supporting the questions at the end; the senior officer package does not mirror it in format, and contains links to policy where information is available. The issue over this disparity was first raised when the products were "finally" reviewed in October, and there was a clear understanding that this would be resolved – it's not!

The meeting I have on Wednesday is to ensure that the two training packages, which should not be vastly different from each other, are aligned – the senior officer one echoing format and much of the content, with a slight variation because of the difference in knowledge required (e.g., not so much "how" but more "why" and "by whom").
