## Fleshed some detail out.

I do have a huge fear of the search for blame whilst still in the response is becoming damaging to the response and testing relationships beyond what they need to be. Stating the obvious I know, but it wont help us in our role of supporting the LA response. It is clearly and would only be from us from the LA perspective which could destroy the relationship we have with them. The SCG today had a focus of unity of messaging and response which would be helpful for the Mayor to support.

Sorry I know we are probably all thinking that but all of this will come out in the enquiry when emotions have reduced rather than now. Easy to say I know, more difficult to have any chance of putting that across.

Another option would be to provide the first Te paragraphs which are in published documents and do not provide operational details but explain the procedures we have that could have been invoked, the mayor could pose the question to John why they didn't giving them the chance to provide their rational at the time rather than the damming timeline that has the benefit of hindsight?

Sorry if that doesn't help or is not my place to say.
