Since the meetings last year you be well aware that there have been a number of high rise incidents- some of which I have been able to attend.

Some of the learning is recorded on the IMP other issues have been discussed but wont necessarily appear on the data base

Examples being

Failure of branch equipment due to mechanical failure of the branch itself or due to blockages due to debris from within the riser then problems in releasing pressure to replace blocked branches as the new Mercs don't allow water out of alternative outlets

The benefits of having a command team of personnel at the bridgehead and at ground level. I cant recall a radio failure but can recall incidents when comms are blamed but its actually down to the span of control and pressure during the escalating stage of the incident

Duplicating equipment up at the bridge head to deal with different scenarios-example-multi first aid bags to deal with multiple casualties

Reoccurring themes are the self evacuation of residents, the request by the local authority to be informed at the earliest possible time of incidents within their premises

I don't claim to have an exhaustive list but wondered if in the light of the recent incidents there may be benefit in looking at some of the points to incorporate them in the revised note if time scales allow
