Good Morning,

At the last meeting Andy asked us to bring any thoughts we had on command decision making to the next meeting, so I thought I'd share the LFB perspective in time for you to consider and discuss next week.

At present, LFB have made a strategic decision not to move away from the Decision Making Model (DMM) as it is felt that there is insufficient evidence to support this when balanced against the business change implications.

The DMM has served us well since implication and has been used at many hundreds of thousands of incidents, supporting millions of command decisions. In fact, the only time it has been found not to work when subject to our rigorous incident review processes is when it hasn't been applied properly — which is obviously a training implication. The model has also stood up to legal scrutiny at a number of high profile cases.

However, we do acknowledge that the DMM could be improved to take account of recent doctrine changes and to improve understanding. We have therefore developed the attached diagram with descriptors to help our Incident Commanders understand requirements. This has been through our internal operational staff engagement process and has received good feedback, so I am happy to share it to inform user group discussion.

I understand from my work on National Operational Guidance for Major Incidents that NOGP are considering commissioning further research to provide some evidence to the service for incident command decision making above level 1 (CM/WM).
