I have excluded items such as demolition that are not controlled under the Building Regulations.

The estimated cost for controllable works has been taken as £4,240,000.

The total building control charge for the project is £11,171 plus VAT

This is made up of a plan charge of £4,468.40 to be paid/invoiced/coded for when the application is made and an inspection charge of £6,702.60 following the first inspection.
