This is a statement about my companies' involvement in GRENFELL TOWER in the ROYAL BOROUGH OF KENSINGTON AND CHELSEA.

I am the above named person and I am a Director of ALL PROJECTS LTD and I have authority to speak on behalf of the company. ALL PROJECTS is a company that produces documentation with information supplied from the companies that hire us.

We were contacted by a David HUGHES who is a contract manager for RYDONS which is a main contractor in the construction industry asking if we would like to provide a quote for work in producing a building manual for work they were involved with at GRENFELL TOWER.

We have been successful in winning the work which we completed between FEBURARY 2016 and SEPTEMBER 2016 in which we produced the building manual for the main building, boxing gym and nursery with the information supplied to us by RYDONS. For this work we have charged £2400 (two thousand four hundred). We were not informed of which companies we had been competing against nor as to why we were awarded the contract. We delivered the manuals digitally to RYDONS. During the

work we have visited GRENFELL TOWER 3 times.

Our company had no involvement in the construction and/or maintenance at GRENFELL TOWER. We are not aware of who was in charge of health and safety at the site or of any companies other than RYDONS that had involvement in GRENFELL TOWER. We have had no dealings with any resident's groups, blogs or forums and are not aware of any complaints or legal proceedings involving residents of GRENFELL TOWER. We are not aware of any fire safety advice or measures at GRENFELL TOWER either before, during or after the renovation work.

We were aware that GRENFELL TOWER was a residential block of flats however we were not informed of its size nor given any information on its residents at the time.

I understand that the material we have provided to Police may be shared with the Public Enquiry investigating the Grenfell Tower Fire. I am willing for any material handed to the criminal investigation to be shared public enquiry.
