I think you must have me confused with someone else. I am running a business, taking on another one, launching a cultural development programme for a 9,000 employee company – and am half way through similar for a 12,000 strong company, and taking care of a family. And that's just the last three days. I do not have the time or inclination to vent frustrations.

Victoria said she would visit the community again at the end of the programme. Please could you let us know when that will be, or when you will tell us.

We can celebrate the successes of the programme of works, as there are many, and address any outstanding issues from our last meeting. If when she comes there are residents here who want to tell her about their experiences, and those are a poor or shocking reflection on the TMO – that isn't my doing. I remain surprised that so few elected people want to listen and act upon what there is to hear about the management and leadership of the TMO.

Dear David,

Thank you for your further email. I entirely understand that this is the most pertinent matter to the residents at present, but I am afraid you must also accept the pressures on Victoria's diary – she has to balance the needs of all constituents, and for new diary requests we are currently looking three months ahead. I am almost certain a meeting sooner will be possible, but it means fitting it around an already full diary, which in essence limits potential dates to when Victoria is already in the area. We will be in contact as soon as a date presents itself, but almost certainly not this week. I am sorry to sound unreasonable, but I am afraid this is the reality.

Secondly, in discussing it with Victoria, it would be helpful for me to know what practical assistance you feel she can give at this stage. Whilst, as you know, Victoria is aware of the problems and is happy to continue assisting where she can, the Borough's Housing and Scrutiny Committee is entirely beyond the authority of a Member of Parliament and Victoria could not attempt to intervene. I must be frank in saying there is little point to a meeting if it is simply to vent frustrations.

I would be grateful for your thoughts.

It is urgent that we meet with Lady Borwick. Councillor Marshall appears to be distancing himself from his and the Housing & Scrutiny Committee's decision to investigate the management of the Grenfell Tower Improvement Works. Is no one going to hold the TMO accountable for the way they managed the project, and is everyone at the Town Hall going to buy in to the TMO narrative without questioning it or seeking an alternative view? When the majority of residents are dissatisfied with the way the project was handled, many with shocking stories to tell, I believe something has to be done.

Please could you respond with immediate effect.
