I am writing to you on behalf of the residents of Grenfell Tower who have been meeting every Wednesday evening for the past six months in the community rooms at the base of our tower block.

Last night, a member of our resident group was informed by Siobhan Rumble (Manager, Lancaster West Estate) that the community rooms were going to be closed from next week and that our resident group would have to find somewhere else to host our meetings until the new community space in the tower opens (in November?). We were given no prior warning about this planned closure, and Siobhan said the TMO would not be assisting us to find alternative premises in which to hold our meetings. This seems very poor given the ongoing construction works and the developing relationships between TMO and the group here. Whoever decided to communicate the information in this manner, and without any prior consultation, did not consider the impact it could have on how residents may perceive the TMO.

Please could you confirm or otherwise if a room will be available to us for our meetings between now and the time of the new community space being open? This would help facilitate relationships between TMO and the developing TMO Compact. Our next meeting is at 645pm on 2nd September 2015.

Or better still, please could you arrange for a meeting room to be made available for the group / TMO Compact to meet on a weekly basis (at 645pm on Wednesdays) from 2nd September, at a location close to Grenfell Tower? The Academy or Sports Centre would be ideal.
