I was wondering why Mr. Daffarn chose those dates to seek information, so I checked my diary for that period and found the following:

- On 26 September 2012 the KALC planning application went to the Major Planning Developments Committee. The report, allied documents and Committee minutes are available on the Council website (all attached for your convenience).
- On 4 October 2012 I have a KALC Resident's' Forum in my diary. If it was held, there will be minutes available from Ms. Johnson's office.
- On 6 October 2012 the Notting Barns ward councillors had an informal meeting with the Grenfell Tower leaseholders but there are no notes or minutes of that meeting.
- On 8 October 2012 the Community Channel transmitted a programme on the KALC issue in which both Mr. Daffarn and I featured. Mr. Daffarn may have this on his website.
- On 23 October 2012 there was a drop in session for residents about the KACL development scheme. My diary does not indicate where it was held but the venue would have been either the EMB Rooms on Lancaster West Estate or the Notting Hill Methodist Church in Lancaster Road. Ms. Johnson's office may be able to advise where it was held and also provide any notes that came out of that session.
- On 31 October 2012 there was a presentation about KALC to the Whitchurch House Residents' Association at 11 am. I think Cllr Atkinson attended that and Mr. Daffarn may

also have been there. There may or may not be minutes or notes of that meeting, which could be obtained from Mr. Chamchoun at the TMO hchamchoun@kctmo.org.uk if any are available.

- On 14 November there was a meeting of the KACL Residents' Forum and minutes are available from Ms. Johnson's office.
- On 14 December there was a meeting of the KACL Residents' Forum and minutes are available (attached).
