Siobhan has asked me to respond to your enquiry about the recent fire safety exercise at Grenfell Tower. I can confirm that Steve Cunningham from the North Kensington Fire Station was very pleased with the exercise, expressed his appreciation for the cooperation of the staff and the residents and confirmed that he felt it had provided a good learning event for the crews. Further, I can confirm that five fire engines were in attendance for this exercise and parking these vehicles did not present any particular problems.

I would advise that I have subsequently discussed with LFB Officers the possibility of continuing with these familiarisation visits and we have agreed a tentative timescale of September for a similar event at the Silchester high-rise blocks.
