Dear all,

I believe we have now reached around 40 or 50 signatures, and we want to press on for more.

To speed up the process, please do not worry about asking the additional questions of people in the spreadsheet. Sometimes it takes 20 minutes or more to get the answers. Whilst it is very useful to get the answers, I believe what we need most urgently are signatories to the petition.

Eddie, Marcio and I are going to be in the entrance to Grenfell Tower between 3 and 4.30 / 5pm today to ask people if they would sign the petition. And Marcio and I are going to knock some doors in the next couple of hours. Clare and I will be doing likewise tomorrow afternoon too. If anyone else can volunteer some time, please let me know.

The Scrutiny Committee meets on Wednesday, so we need to get as many signatures as we can today and tomorrow. If you have sheets of paper with signatures then these need to be with me some time tomorrow.

Hi all,

As of 5pm yesterday I know we have 24 signatures for the petition!!! :)

Judith and I both started talking to people in the lift, etc. So you may find that some people on your floors have signed already, but that's ok :). We have signatures for residents in flats 155, 15, and 35 (which are on floors some of you are looking after).

Some interesting things...

- Of the people I have spoken to only one person has answered "Yes" to the question, "Are you satisfied with the manner in which TMO managed and conducted the refurbishment project?". Everyone else said, "No".
- The majority of people felt harassed / lie to / threatened / pressured.
- A number of people want to come along to meetings now, to get more involved in some way. If you meet anyone like these, please take their mobile telephone number.
- And I met two people yesterday who have the HIU in their hallways and would like it moved. The majority of people with the HIU in the hallway do not want it moved; many have had enough hassle and inconvenience already and do not want any more.

Let's see how quickly we can get to 100 signatures. Maybe before the end of the weekend? Please just talk to and ask anyone you see!

Hi all,

Please find attached blank copies of the Petition, and questions we developed at last night's meeting.

As we agreed, the following people are taking responsibility for canvassing opinion on the following floors:

- Floors 19 to 23: Marcio (with David)
- Floors 13 to 18: Eddie (though he hasn't agreed to it yet, that's what you get for not being at the meeting with jet lag ;)
- Floors 8 to 12: Antonio
- Floors 7: Turufat & Betty

- Floors 3 to 6: Hewe & Meron

I will deliver printed copies of the documents above through your doors today.

Judith / Clare, I believe you are both willing to help canvassing floors. As we would like to door knock in pairs, it would be ideal if you could help Antonio or Eddie, or knock together as a pair. Who you help will probably depend on when you are available, and if you have more than one time you could help over the next few days. You may end up knocking on doors with me too, as I may take on 3 to 6 too, as Hewe & Meron may not be able to knock those doors until Sunday. Please could you reply to let us know what slots you could help (for instance Friday morning, Saturday after 3pm, or Thursday evening)? Then I will match people up!!

It is our intention to reach everyone in the Tower before the end of the weekend. Ideally we will be able to try each floor twice (day and evening) in that period.

I have also attached a copy of who has already signed for information. Please knock on those doors too, as we want to ask the questions as well as get the signatures on the petition. We are doing this so we can gather evidence about how the works have been managed and led by the TMO, so we can ask for proper consultation for other blocks in the Borough, and for TMO to be held accountable for their actions to date towards the people of Grenfell Tower.

Please keep in touch with how you are getting on, so I can keep track of how we are doing I may check in with everyone too :).
