So three points emerged about the surge:

1. It was the result of arcing on a main cable into the building.
2. The whole length of cable was replaced, not just a patch at the point of arcing.
3. A power surge filter has been installed to protect the building from surges elsewhere on the network.

So far, so good. There are, of course, other more technical questions but I do not feel able to pursue it any further.
