> Dear Mr. Christie

> I note that works to these premises were going on into the evening on Saturday. Has the Council considered asking the Westway Trust for a brief extension to the lease to the former Maxilla Children's Centre? Surely this would be better than putting the children into clearly unsuitable, subterranean premises with no dedicated outside space? I understand that the Trust would be amenable to such a request.

> Furthermore, this has removed access to a vital facility for the residents of the Lancaster West Estate. You may be aware that there are a number of ongoing problems surrounding the refurbishment of Grenfell Tower which requires regular consultation between the builders, the residents and the TMO. The residents now no longer have access to their community rooms to enable this consultation. Can you please advise what alternative facilities the Council will be making available to the Grenfell residents for this purpose? They have asked for a room at the Leisure Centre to be made available but they do not have the funds to pay for its hire.
