Dear Councillor Will,

At a recent policy board meeting Cllr Campbell mentioned that an enquiry had been received from Councillor Atkinson regarding the Grenfell tower provision.

I can confirm that the child care provision does include an offer for vulnerable two year olds.

Another question was whether there was scope for any children's centre service delivery, either at the current interim site, or at the planned future site.

Unfortunately the whole footprint in both sites will be required to deliver child care provision – the core business – at a level that makes this operation sustainable.

The provider will be linked into the local children's centre via outreach, and families attending there will be encouraged to register at one of the local children's centres and access their services.

I hope that these responses are helpful.

Please let me know if there is anything else that I can assist with.
