In response to your email.

A Grenfell Under 3's Project: I understand that RBKC Family and Children's Services are working with the nursery. You appreciate that the nursery have 6 months rent free at the resource centre to get their Business Planning in place and then the nursery have to decide if they are going to return to the new premises at a commercial rent or not. I think it is Paul Williamson at RBKC FCS who has been working with them, and I have no direct involvement in these discussions. The area is designed as a nursery and there is no plan to change this use.

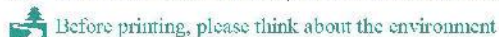
B The boxing club: They initially have to surrender their current lease on the premises to vacate Grenfell, which still has about 10 years to run. I have no reason to believe they will not return to Grenfell, but once they have signed the subsequent legal paperwork then there is a commitment to return and the boxing club area will be built out to the agreed specification.
