Dear David

I have had a meeting with the TMO at senior level and we have agreed that the TMO will recognise a properly constituted Compact for Grenfell Tower residents. If this can happen, then the TMO will work with the Compact, ward

councillors and Cllr Borwick MP to take issues at the Tower forward on a collective basis. I also made the point, which they accepted, that they should engage with you rather than your landlord, since you are a resident of the Tower – and the whole point of resident engagement is that it applies to people who actually live on the TMO estates. So hopefully that is another hurdle overcome.

I hope you find this helpful and that the residents can organise a representative Compact to address any further problems at Grenfell Tower. (I also made the point that residents need some sort of “reward” at the end of the project, given that they have not only suffered the construction of the Academy, the demolition and reconstruction of the Leisure Centre but also massively intrusive refurbishment works on site that have not been handled as well as they could have been.)
