Many thanks for this. I have agreed to attend the meeting with Ms Williams and Ms Bartholomew and have given the Leaseholders' Association details of my availability, but have had no reply.

For the avoidance of doubt, I think residents will be re-assured only if they have a report from the London Fire Brigade on the safety of these gas pipes. The major fear relates to the ongoing anti-social behaviour in the stairwell and the fact that the valves may be vulnerable to interference.
