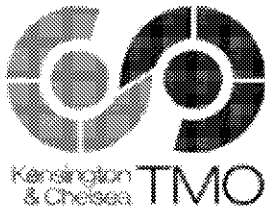
Please forward the floor plans for the residential units to Clare Wise at RBKC.
