I suppose we could say something to the effect that on larger programmes such as these will compliment estate regeneration there will be greater Council officer and Member involvement, more focused working on assessing the needs of individual tenants and perhaps going into greater detail with residents about what the costs are and why the budget will only stretch so far in the context of what we can spend across the stock on capital works. Now there is a greater use of digital media we may for some age groups focus some of our efforts at making information more accessible on-line, whilst respecting the fact that for some they still prefer face to face communication.
