The wheelchair units look fine. I would suggest that the one bedroom units don't need a bathroom *and* a second toilet. The space for the second toilet could be better used for a washing machine and/or storage. They also need to show a wet floor shower in the wheelchair accessible bathroom instead of the bath and a full size wash hand basin (as opposed to a Part M pack wash hand basin).

I have advised Jane about the change in bedroom size and wheelchair unit configuration. We are both happy with the revised proposal as we have a high need for wheelchair accessible units in the borough.
