Dear all.

I have just had a conversation with Alexis about this and my understanding of the meeting tomorrow is that the intention is to mainly discuss funding of the assessment process. Is that correct?

I am not sure that this is necessary.

Alexis has informed me that the assessments are a requirement upon us and one in which so far, by doing it in house, we have failed to satisfy LFB. Therefore there seems to me to be no alternative than to commission an external agency to do this work. I would hope that the TMO could proceed quickly to procure a suitable consultant to undertake the assessments. Obviously cost and expertise will be key in this.

In relation to budget, it would also seem to me as a non Finance person to be clearly an HRA responsibility to pay for this so effectively whoever commissions it the monies will come from the same source. I have copied Roberto in so he can confirm or contradict this assertion.

Regardless of this, given it is Alexis's professional view that these need to be conducted urgently in the high priority blocks, it seems to me that the TMO should proceed to commission the work in order to avoid the service of an enforcement notice, and we can, should the HRA not be responsible for the costs consider which budget funds them later. (But not too much later).

Please let me know your views.

Good afternoon Pam,

I have received a phone call from Angus Sangster, Senior Fire Safety Officer from the London Fire Brigade. He said that he has not heard again about the remedial works to be carried out after their visit to Gillray House. They are giving us a deadline until this Friday  $10^{th}$  July 09 to present the action plan in writing to them. Otherwise they will issue an enforcement notice. After the fire in Camberwell tower block, they after great pressure to ensure buildings are safe.

Really what they are asking is for the TMO to identify their high risk buildings (only one stair case as the fire exit route), medium and low risk; and how and when the fire risk assessment will be carried out.
