Hi Rob,
we usually consider requests such as this via the Community Safety Commissioning Group which I chair and whose membership includes Detective Superintendent Raff D'Orsi (copied). Unfortunately Raff is [REDACTED] not back [REDACTED]. Given your time pressures I am going to take the unusual step of agreeing to match fund 50-50 outside of these processes. This will be £10K for capital and/or revenue spend but will need to be spent and accounted for by the 31 March. We will also need a funding agreement with details of the project signed off before we release the funds. Mina Cobbinah is the Commissioning Manager for Community Safety in the Council and will be able to provide this in due course. We would also like to see the project proposal and will be particularly interested in how you will engage with the Council and community organisations to identify those vulnerable

residents. There may be opportunities to align this work to other projects to increase added value. For now you can proceed on the basis of a commitment of £10K.

Hi Stuart,

I know that last time we met you made me aware of the money saving that you had to achieve for next years budget, however this opportunity I thought that I would have to put past you as it is too good an opportunity to miss:

Community Safety Investment Fund

Following agreement of the Fire Authority to adopt option B of the 2016/17 budget proposals, a one-off Payment of £1 million has been established as a Community Safety Investment Fund . The strategic direction of how this money should be spent is that it must be directed into the homes of the most vulnerable people across London to be used on fire safety equipment such as sprinklers, personal protection systems, telecare and other recognised measures that reduce risk.

A project has been established to manage the allocation of this fund and the Brigade will soon be approaching Borough Commanders (BCs)/Partners and inviting them to put forward bids for funding inline with the above strategic direction. I have done a little further digging around on this, I wanted to make a bid of £10,000, would RBKC be able to match fund this?

What will we get, I am looking at a stock of carbon monoxide alarms that we will fit free of charge to the most vulnerable, I would also like to explore further the possibility of acquiring a personal protection sprinkler system for the Borough (portable) although these do have maintenance costs attached to most of them. I will also be extending the pilot that I have run in the Borough for fire retardant throws, mats and night ware. (we already supply bed linen).

I am up against time on this one Stuart as I have just returned [REDACTED], if possible would I be able to get a steer by Friday??
