- TMO awaiting quote from Rydon for lightning conductor work, to get it reinstated and certificated, as a makeshift until new frame becomes the conductor
- 4 copy of your RAMS for working in the basement
- 5 information on your proposed secondary route from the basement not using the hatch
- 6 photo of signage around showing that you are notifying contractors of this new route, including any induction information
- door at the bottom of the basement stairs to be fire door you are giving me price for repairing frame, overhead door closer etc
- you are filling holes with f.r. foam to the ground floor electrical cupboard where the mast climber cables run. Please send thro photo to close this off
- 9 you are getting me the elec certificate for the new lights to the ground floor entrance
- 10 you are getting me the certificate to show the fire panel moved to the new entrance was tested
- 11 you are sending me a copy of your RAMS re working in the lower 4 floors and evacuation
