As yet these are not our (Max Fordham's) proposals quite yet but are proposals that we have been given from KCTMO to incorporate into our works that we intend to modify to work with the new layouts and fire strategy for Grenfell Tower. I have had a look through the proposals and I can't find any reference to back-up power supply to the smoke extract fans or control equipment. I have not seen any batteries in the roof top plant room so I don't think the fans currently have a back-up power supply, although there is one room in the roof top plant room that I have not been able to get access to. I assume that a back-up power supply is going to be needed as part of the updated smoke extract strategy?
