My responses in red below. Please give me a call on my mobile on Monday if you wish to discuss. [REDACTED]

1. Rydon are proposing a face fixed Aluminium cladding system in colours to mirror those submitted for planning. How do you advise presenting this to planners for discharge? Is a meeting required or simply supply materials proposed? *As you know we have met the LPA on a number of occasions and presented a range of materials over the course of this project to date. I would recommend that a meeting with them to present early thoughts on materials, with physical samples, would be appropriate. I would suspect that they will have queries and issues and may well ask for alternatives to be explored for certain proposed materials / colours so I would also recommend exploring options for the cladding at this stage. An initial thought - I would be concerned if 'face fixed' means visible fixings.*
2. It is proposed to remove the crown to the top of the building as for maintenance reasons it would be prudent to enable abseil access if ever required in the future. *Again, the crown was the subject of much debate and to get it to its currently proposed height (i.e. reduced from where the LPA started) took some good negotiation. I consider that the LPA would not want it taken out of the scheme, but also what would go in its place? A change from the approved plans would require a further application, in this case probably an application for 'minor material amendments' which can take 8-13 weeks to determine.*
3. The louvre panel proposed for the windows is proposed to be removed as has caused wind reverberations complaints and issues on alternative schemes. *The LPA have raised concerns about the louvred panel previously and had wanted to be convinced that its quality will be good enough, as well as being aesthetically pleasing. Whether they will accept a change will depend upon what you are proposing instead. The change from the approved plans would again require an application although if the*

appearance does not change significantly we may be able to use the 'non-material amendment' approach which is only a 28 day turnaround.
