Reynobond's BBA certificate includes the following statement regarding service live: "(The product) has an ultimate service life in excess of 30 years...can be expected to retain a good appearance for up to 20 years"

VMZinc (roof): "Roofing constructed with the sheets will have a minimum service life of 60 years..." (You would expect an even longer life when used as a façade cladding)

Zinc and ACM are not equivalent in terms of service life.


